Exxon Mobil Corporation is a multinational oil and gas company that is based in America. It's a descendant at of the Rockefellers standard oil company and it was formed in 1999 from the merger of the Exxon and Mobil companies. It's headquartered in Irving, Texas. The company is one of the world's largest publicly traded companies and has been ranked the number one or number two for the last five years. By the end of the year 2007 the company's reserves stood at 72 million oil equivalent barrels while its production rates were expected to last for more than 14 years (Hrebiniak & William, 1984).

The company has 37 oil refineries in more than 21 countries constituting a combined daily refinery of approximately 66.3 million barrels. Exxon Mobil is recognized as the world's largest refineries and this title has been associated with the former standard oil since the in corporation in the 1870s. In addition to that the company is largest of the six recognized oil super majors. Exxon Mobil owns hundreds of other similar subsidiaries including the imperial oil limited in Canada and the sea river maritime which is a petroleum shipping company. Works Cited

- I DO NOT need a works cited page as long as you are using the 15 documents I have provided for you. If you do outside research (which you are welcome to do) and cite any of that information in your essay, then I will need a Works Cited Page.
- Remember, my notes/lectures are considered common knowledge and do not need to be cited in your essay.
 - Example: Harry Truman was President of the United States during the end of WWII. We all know that, so you don't need a citation to go with that information.
- There are no minimum or maximum amount of sources you have or need to use in your essay, however, it is impossible to write this essay without sources, so just be vigilant when writing your essay.

Quotations

- You can quote within your essay, HOWEVER, the rule in history is that you only want to quote when what the person says is so good, you can't say it any better. So quote less, paraphrase more. If you quote too much, it could lead to a low score.
- Quotations should be no more than 3 lines when typed. If your quote goes over 3 typed lines, then that is a block quote. You can look up online how to do a block quote.

Example: Truman's Diary

- In Truman's Diary, he states "The target will be a purely military one and we will issue a warning statement asking the Japs to surrender and save lives" (Source 1: President Truman's Private Diary).
- In Truman's Private Diary, he describes how terrible the atomic bomb was and whether or not to use it on the Japanese. Truman understands that if the bomb is used to end the war, it will be detonated over a military target (Source 1: President Truman's Private Diary).
